- IV. Financials (Lee Ann)
 - a) First Quarter Financials reviewed
 - b) Budget Review reviewed
 - c) Reserve Projects reviewed, discussed potential projects for 2023-2024. \$25,000.00 approved for sprinkler head replacement.
- V. Jesse Danford Update on grounds and proposal for sprinkler head replacements.
 - Sprinkler head replacement for Valley West only (not The Lakes) will be \$10,236.60 in parts, plus labor, estimating \$10,000.00. The total budgeted is \$25,000.00.
 - A new clock/faceplate is needed in Valley West, about \$2,500.00, plus about \$2,500 for install. Total budgeted is \$5,000.00/
 - Plan for Bozeman Cost Share trees in summer 2023: 5 in Valley West, 4 in The Lakes, \$900.00 total. Planted 30 trees in 2022. There are 348 trees in the HOA's care. Watering new trees and mulching new and existing will be about \$7,000.00.
- VI. Old Business: Association Issues
 - Ciaran Montana entity offering grant money to clean up the ponds, contact with Mike Duncan at FWP HOA needs to forego use of chemicals in the ponds to gain FWP support to obtain grant.
 - Asphalt repair to 434 Stafford/alley alley is higher than yard. Multiple contractors said the owner needs to build a berm or raise the level of their yard.

- Ownership/title for VW open spaces; to pursue in Q1 2023-2024 (Margot) budget increase approved to move forward; 5-year waiting period has expired since Bozeman Lakes LLC was first notified.
- Enforcement of ARC processes (Lisa) Intrinsik has begun to implement this process for new home construction in both VW and The Lakes, including an inspection near the end of each build.

VII. New Business: Association Issues

- East Lake surface water rights Margot advised moving forward now. Lisa will contact Deb Stephenson to contact Morrison-Maierle to obtain needed records.
- Lakes Design Manual/Covenants
 - Replace Form C with Form 4 approved.
 - Color scheme requirements no changes
 - Fences on corner lots will implement Intrinsik's suggested revisions.
 - Restrictions on use of HOA parking spaces in the woonerfs Margot researching for both VW and The Lakes.
- House + ADU rental restrictions in The Lakes we will not pursue any changes.
- 2023-2024 Budget Planning
 - Sprinkler replacements (reserve project?) yes, \$25,000.00
 - Asphalt repairs in 2023 (reserve project?) yes. Waiting for estimates, patchwork only.
 - Increase attorney fees for 2023-24 (VW open space ownership action) \$10.000.00
 - The Lakes stormwater facilities maintenance (\$2.5k/year for 2 facilities) \$2,500.00
 - Ponds maintenance \$15,000.00
 - Decrease trees budget for 2023-24? (one year only) \$16,000.00
